The Southern Funeral Director Magazine is a third generation family-owned publication with editorial that appeals to the funeral, cemetery and cremation industries. The publication was launched by John W. Yopp, Sr. in 1919 and continued with his son, John Yopp, Jr., from 1955-1991. 




#### Ginger Hardy, Vice President of Client Relations, Southland National Insurance Corporation


Jim Taylor, Convention Chaplain, Funeral Director and Pre-Planning Counselor

## Garry W. Hood, TFDA Secretary/Treasurer, Hood Funeral Home, Crossville, TN




